## Termination of the Balanced Equity Management – Australian Shares investment option

Host-Plus is responsible for determining the overall investment profile of the Fund and for selecting, monitoring, managing and removing Investment Managers.

Balanced Equity Management Pty Limited has been one of Hostplus' core Australian equities managers since January 2003. Following a recent strategic review of its investment portfolio and investment managers. Host-Plus has determined to close the Balanced Equity Management – Australian Shares investment option.

## What do you need to do?

As an investor in the Balanced Equity Management – Australian Shares investment option, you are required to switch the entirety of your investment in that investment option to an alternate Hostplus investment option by 4pm AEDT, 8 February 2021. You can make your switch via your Member Online account at **hostplus.com.au** 

Please note that should you not have made your alternative selection by 4pm AEDT, 8 February 2021, your investment in the Balanced Equity Management – Australian Shares investment option will be transferred to the **Australian Shares** investment option.
