

AN IMPORTANT UPDATE TO YOUR INVESTMENTS

17 July 2025

We're making changes to our investment menu and want to let you know what's happening and what it means for you.

What's changing?

On **30 September 2025**, we will be closing two of our investment options:

- **International Shares – Emerging Markets**
- **International Shares (Hedged) – Indexed**

If you still hold these options on 30 September 2025, we'll move your balance to an alternate option. This change will also apply to your future contributions.

Here's how it will work

Closing option	Alternate option
International Shares – Emerging Markets	International Shares Refer here for more information: <ul style="list-style-type: none">▪ Super members▪ Pension members
International Shares (Hedged) – Indexed	International Shares – Indexed Refer here for more information: <ul style="list-style-type: none">▪ Super members▪ Pension members

These alternate options offer the closest match to the closing options, with similar characteristics such as investment objectives, investment fees and costs, asset class exposure, level of investment risk and minimum suggested investment time frame.

You can still access Emerging Markets through our International Shares option, which currently invests about 27% in these markets and can go as high as 40%.

Why we're doing this?

We regularly review our investment options to make sure they're working in our members' best interests. A recent review showed that member take-up for these two options has been low and the alternate options share many of the same characteristics as the options being closed.

Closing these options will help us manage overall costs for our members and will simplify the range of products members can choose from.

What this means for you

- If you're invested in either of the two closing options, you can switch out of these options any time before **4pm (AEST) on 26 September 2025**. Simply log in to Member Online and click through to the "Investments" section and select "Change investments."
- Alternatively, you can stay invested in the closing options until 30 September 2025 when we will move your money to the alternate investment option, outlined on the left.
- If you're no longer using either of these options, you don't need to do anything.

Hostplus offers a range of investment options to suit different goals and risk appetites. If the alternate option we've selected isn't quite right for you, you're welcome to choose another that better aligns with your preferences.

Key dates to remember

Date	What's happening
29 August 2025	From this date, you will no longer be able to switch into the two closing options or set up future contributions into these options. You can continue to stay invested and keep contributing to these options until their closure.
26 September 2025	This is the last date to switch from the closing options to another Hostplus option of your choice before their closure. You need to make sure your final request is submitted by 4pm (AEST/AEDT) on this date.
30 September 2025	We will close the two options and move any remaining balances to the alternate investment options outlined above on this date. This will also apply to your future contributions.
